## 2018 CFDA CLUB (ANNUAL RE-AFFILIATION) AGREEMENT

This agreement is between the Cowboy Fast Draw Association, a LLC in good standing registered in Deadwood South Dakota & Nevada (hereafter CFDA), Quick Cal, Executive Director - P.O. Box 5 – Fernley, NV 89408; Phone: 775-575-1802 [info@cowboyfastdraw.com](mailto:info@cowboyfastdraw.com) and \_\_\_\_\_

*Whereas the CFDA Affiliated Club wishes to continue to conduct events under the guidelines of the Cowboy Fast Draw Association and agrees to follow the rules, interpretations and policies of CFDA management for conducting such events, and, Whereas CFDA wishes to provide means for clubs to affiliate with the CFDA and promote the sport of Cowboy Fast Draw.*

### **The following items apply to this agreement:**

- MEMBERSHIP:** Affiliated Clubs must require CFDA membership for 100% of its “Home Club” Members. Clubs have the option to create a policy regarding how and when new members will join CFDA.
- MEMBERSHIP LISTS:** Clubs will submit a list of Home Club Members each year along with the Club Renewal Application/Worksheet and remit by the deadline shown, so that CFDA is able to fulfill its obligations to the Insurance Company. **All clubs whether participating in the CFDA Club Liability Insurance Program or not MUST still report a membership list, according to CFDA rules.** CFDA must provide membership numbers to our insurer for both our CFDA Affiliated Club Program and our CFDA Master Policy. Please use real names and aliases (if available) on membership lists. CFDA will verify that club members are members in good standing of CFDA and provide renewal dates, when the signed Agreement is sent back to the club.
- “HOME CLUB” MEMBER DEFINITION:** A Club’s Official Membership List should only include “Home Club Members”. Home Club Members are defined as active members, including spouse or family members, who consider and declare your club as their Home Club. The Official List should not include “Associate Members” who are members of multiple clubs that have not declared your club as their Home Club. The Official List should also not include “Legacy Members” who possibly joined your club as a Founding or Life Member, and are no longer active members of your club or CFDA; or have declared another CFDA Affiliated Club as their Home Club.

**(Important: ALL 7 Pages must be returned with signatures and payment no later than December 1<sup>st</sup>, 2017!) So that we can report final numbers to our Insurance Company and qualify for Named Insured Status**

4. **INSURANCE DEADLINES (IMPORTANT!): Clubs not returning Re-Affiliation Agreement & Payment by the December 1st Deadline** may not qualify to be inserted as a “Named Insured” on the following year’s CFDA – NRA Endorsed Shooting Club Liability Insurance Policy, which provides an extra level of coverage for a club and its members wherever official CFDA Affiliated Club events are held.
5. **CLUB NOT PARTICIPATING IN CFDA INSURANCE PROGRAM:** U.S. Clubs that choose not to or cannot participate in the CFDA - NRA Endorsed Shooting Club Liability Insurance Policy must provide their own \$1,000,000 Liability Policy and provide a certificate naming Cowboy Fast Draw Association, LLC as an additionally insured., to become or remain a CFDA Affiliated Club, by December 31st. Affiliated Clubs that are not participating in the CFDA Insurance Program must provide Additionally Insured Certificates from their own policies to cover property owners where they carry out CFDA functions **(SEND WITH AFFILIATION FORM)**.
6. **INSURANCE NON-QUALIFICATION:** No club may qualify for the CFDA Insurance Program unless they exclusively offer the CFDA shooting program. Clubs who engage in any other organized forms of shooting sports must provide their own \$1,000,000 Shooting Club Liability Insurance Policy and provide the Cowboy Fast Draw Association, LLC a certificate as an “Additionally Insured.”  
**Note:** This does not apply to CFDA clubs who exclusively offer CFDA events and are part of a larger shooting club that offers other shooting programs. They may still access the CFDA Insurance Program as long as their particular club within a larger organization only offers CFDA as a Fast Draw activity.
7. **CFDA RULES AND REGULATIONS:** CFDA Affiliated Club hereby agrees to abide by the latest CFDA Gunslinger’s Rules & Handbook and any addendums, policies, and decisions by CFDA Management.
8. **RELEASE FORMS:** CFDA Affiliated Club hereby agrees that it shall require all participants in any sanctioned activity including contests or “Try Cowboy Fast Draw” events to sign the approved Release Form that can be downloaded at the website under the Master Signup Sheet or use a form with the following wording:

“I agree that I will not hold the Cowboy Fast Draw Association, LLC, The CFDA Affiliated Host Club, Land Owners, or Lease Holders, Sponsors, (or) any officials, officers, employees, members or volunteers of such, responsible for any injuries as a result of my participation in any part of this shooting tournament or related activities. I acknowledge that the sport of Cowboy Fast Draw, by its very nature, has the potential to be dangerous and a serious accident could occur. I assume full responsibility for my involvement or that of the minor that I am signing for. I further agree to follow all rules of CFDA, especially those that involve safety and conduct. I will load firearms only at the command of a Range Officer. I also agree to allow my photograph or interview while participating in this event to be used for promotional purposes by CFDA.”

9. **INSURED LOCATIONS:** Each club that participates in the CFDA - NRA Endorsed Shooting Club Liability Insurance Policy will receive one “Home Range Location” for ongoing CFDA use that is covered. Clubs may have one additional “Home Range Location”, but must fill out the Additionally Insured Application and remit a \$40.00 fee to CFDA. Clubs may also add additional locations for special events such as Town Folk Alleys and contests, but must fill out a CFDA Additionally Insured Application and remit a \$40.00 annual fee for each additional location, plus specify the actually dates that insurance coverage is requested. CFDA Affiliated Clubs are responsible to maintain at least 50% NRA membership to qualify for said insurance. CFDA does not check NRA Membership status and is not liable for lapsed insurance coverage that could occur.
10. **SHOOTING PROGRAMS:** Each CFDA affiliated club will maintain a regularly scheduled shooting program and will provide information to CFDA for publication in the Gunslinger’s Gazette and CFDA Website. Club will also maintain CFDA Range Officer and Youth Safety Training Programs. Clubs may coordinate with CFDA Regulators, who are highly trained and experienced members who volunteer their time to better develop CFDA. Clubs may invite Regulators from out of their area to conduct training. Clubs may email CFDA staff at info@cowboyfastdraw.com with a request, who will then forward the request the Regulator Posse Administrator. It is customary to cover expenses for Regulators traveling from out of town by charging a fee to those who attend courses.
11. **EVENT NOTIFICATION:** CFDA Affiliated Clubs may host CFDA Titled Championships, when available, and will follow the CFDA Guidelines when doing so. Clubs may also conduct club contests, “Try Cowboy Fast Draw” and other demonstrations as they see fit, however, they **must have a CFDA Qualified Range Officer or Range Master (In Charge)**. Clubs may notify the CFDA office to post their special events on the CFDA Website, they may also find that the Discussion Group on the CFDA Telegraph is an excellent resource to make postings for information on their upcoming events or also post results of those

events. It is a very quick way to get information out to members who closely follow CFDA. Also see the CFDA Sanctioned Event Contract for additional details regarding CFDA Titled Championships.

- 12. CFDA LOGO:** Affiliated Clubs shall have the right to use of the CFDA logo for newsletters, brochures, awards, trophies, buckles, contest areas, and advertising. The CFDA Logo is encouraged to be used to promote the Sport of Cowboy Fast Draw and CFDA Affiliated Clubs to the public. The CFDA Logo may be re-produced on official CFDA Affiliated Club banners, club shirts and other club items exclusive for the use of club members. Upon request, the CFDA office will email CFDA Affiliated Clubs electronic files containing the CFDA Logo, several types are available. The CFDA Logo and other trademarked images may **NOT** be altered in any way. *CFDA strongly encourages the use of the CFDA Logo, as it has been promoted nationally in thousands of dollars of advertising and hundreds of media outlets.*

*In order to protect CFDA's trademarks, The CFDA Logo may not be re-produced on merchandise being sold outside of a club or to the general public, without express written permission from CFDA. All requests to use the CFDA logo must be in writing and submitted to CFDA for written approval, other than stated below.*

**13. AFFILIATED CLUB BENEFITS:**

Affiliated Clubs shall receive the following benefits as being a CFDA affiliated club in good standing:

- A. Logo use in club newsletter, brochures, advertising, promotion, and awards.
- B. Support from CFDA Headquarters and CFDA Regulators in building a successful club.
- B. Club Listing and contact information on the CFDA web site, and Gunslinger's Gazette.
- C. U.S. Clubs may order extra Gunslinger's Gazettes in standard bundles of 40 on our website, for a nominal \$15 fee to cover postage.
- E. Contest scorecards, releases and other forms may be downloaded from cowboyfastdraw.com.
- F. Access to the NRA Insurance Shooting Club Liability Insurance, according to Sections 4, 5, and 6.
- G. Opportunities to host State and Territorial Championships, when available.
- H. Appointment of U.S. Marshal to CFDA Advisory Board. (CFDA Life Membership Required).
- I. Liability Release Form may be downloaded from [www.cowboyfastdraw.com](http://www.cowboyfastdraw.com) under "downloads" then print Master Signup Sheet.

- 14. CFDA AFFILIATED CLUB RENEWAL FEE AND PAYMENT:** The 2018 Affiliation Fee is **\$125.00**. For clubs participating in the CFDA - NRA Endorsed Shooting Club Liability Insurance Program the cost is an additional **\$290**, for a total of **\$415**. (Please See Worksheet on Page 6.)

**Note: We are anticipating that our insurance rate will increase another 10% for 2018.**

- 15. CLUBS WITH MORE THAN 12 HOME CLUB MEMBERS:** The CFDA - NRA Endorsed Shooting Club Liability Insurance Program covers **up to 12 members** for each club. **\$12 must be included** for each additional member over the number 12. i.e. 20 members would be 8 x \$12 = \$96 additional.

- 16. \$75 OPTIONAL GUNSLINGER'S GAZETTE FEE:** CFDA Affiliated U.S. Clubs may elect to pay an additional \$75 Annual Gazette Fee and automatically receive a package of 40 Gazettes every time an issue of the Gunslinger's Gazette is published. (Great Recruiting Tool!)

- 17. INTERNATIONAL CLUBS:** Members outside the U.S. who wish to form a CFDA Affiliated Club and conduct sanctioned events in countries other than the United States, cannot access CFDA Insurance. They must provide their own insurance and send proof to CFDA and name CFDA as an additionally insured, wherever practicable. International Club Affiliation Fee is: \$175(us). CFDA printed material may be ordered for cost of postage.

- 18. NOT A FRANCHISE:** CFDA Affiliated Clubs are not franchises of CFDA, they have no guaranteed area in which to operate. They are independent organizations and conduct their own affairs as they see fit. Clubs have no ownership or financial interest in CFDA and CFDA has no ownership or financial interest in any club, other than the set fees stated herein. There is no limit to how many CFDA Affiliated Clubs are in any city, county, state or country.

- 19. FACILITIES:** CFDA only provides rules, regulations and guidelines to conduct a sporting event. CFDA does not and is not qualified to inspect facilities for conformance with building, safety or planning codes (national, local or otherwise.) CFDA, its officers, representatives or agents reject all responsibility or liability connected with property safety management, supervision or code violations of any kind.

- 20. ENTIRE AGREEMENT:** This is the entire agreement of the parties with respect to the subject matter hereof, along with all conditions stated in the latest edition of the CFDA Gunslinger's Rules & Guidelines.

**(Important: ALL 7 Pages must be returned with signatures and payment no later than December 1<sup>st</sup>, 2017!) So that we can report final numbers to our Insurance Company and qualify for Named Insured Status**

- 21. SEVERABILITY:** If any provision of this Agreement is determined to be invalid, illegal or unenforceable, the invalidity, illegality or unenforceability may not alter the remaining portion of such provision, or any other provision of this Agreement, as each provision of this Agreement is deemed severable from all other provisions of this Agreement.
- 22. FINAL AUTHORITY:** CFDA Management shall be the final authority in arbitrating any disputes between clubs or members. **CFDA has a policy of not interfering or taking sides concerning internal club disputes.** CFDA is a private organization and Reserves the Right to Refuse Service to Anyone.
- 23. TERMINATION:** CFDA Management reserves the right to suspend or terminate this agreement in the event that an affiliated club is not following CFDA Rules and Guidelines, especially CFDA Safety Rules, or CFDA Policies.
- 24. REMOVING A SANCTION:** CFDA Management or a CFDA Regulator, acting in their capacity as an appointed representative of CFDA Management, has the authority to bring violations of CFDA Safety Rules, Competition Rules or Policies to the attention of the CFDA Club/Host. If the CFDA Club/Host fails to remedy the violation the undersigned agrees that CFDA Management or a CFDA Regulator, acting in their capacity as an appointed representative of CFDA Management, has the authority to remove a sanction from any event for reasons of not complying with CFDA Safety Rules, Competition Rules or Policies. If the action is carried out by a CFDA Regulator, they shall immediately inform CFDA Management of this action, for which CFDA Management will carry out an investigation. A Club's CFDA affiliation status may be suspended pending an investigation until a final decision is reached by CFDA Management.  
**Note:** A CFDA Regulator must have expressed written appointment by CFDA Management to be the official CFDA Representative at any CFDA Sanctioned Event.
- 25. U.S. MARSHALS:** Shall have the opportunity to represent their club at the Annual Marshal's Muster, or may appoint a Deputy Marshal to represent their club, if they cannot attend. U.S Marshals agree to adhere to the U.S. Marshal's Section found in the current Gunslinger's Rules & Handbook. **U.S. Marshals represent their club in matters of rules, safety, and range operations policies.** Act as Chief Club Range Master, if one is not assigned by Club Management. **Whereas, Club Management (Officers) represent, assign, and/or carry out business agreements between CFDA, other legal affairs, club promotional campaigns, and assign club contacts.**

**We have carefully reviewed this agreement and accept its terms and conditions. We are executing this Agreement as of the date written above.**
