Our event is an all indoors event at the new Churchill County Rafter 3C Arena. With over 300 competitors and their families there for a almost a week, the event is free to the public!

We're a western themed shooting competition sport, we wear old west themed clothing, anything western and we highly encourage all vendors participating in this event to dress western as well if you like, it helps add to the fun of what we do and promote!

For vendor items & products at this event we'd like to see handmade products, unique items, western themed, if possible, *but not necessary,* Items like leather work, metal art, jewelry, western clothing, home décor, outdoor items, kitchen items, holiday & everyday fun stuff.... *Please, no items that belong at the circus or a novelty store.* 

We have very limited indoor vendor spaces; **Only 12 spaces are available** on a first come first served basis. No outdoor vending at this event except for food vendors if needed. We keep our vendor fees low as we want everyone to have a good show. The spaces are 10x12' in size. There are very few electrical outlets available – first come first serve as well. If you need electricity, please make sure to reserve your space early not to be left out.

**You'll need to supply your own electrical cords, <u>tables, table coverings and chairs</u>. There isn't any wall area for banners so please plan accordingly. Art easels are always a good option!** 

As a vendor, you'll receive a vendor packet once you've set up your space, which includes 2 vendor badges, Nevada Sales Tax info sheet and a one-time vendor sales / tax form to fill out at the end of Saturday that will be collected by our staff,

We also would like to ask all vendors upon arrival to please donate an item of at least \$30 or more to be auctioned at our Thursday evening event. All proceeds go to our CFDA Scholarship Foundation which has helped 100's of our young members go to further their education. It's a wonderful fundraiser and we truly would appreciate it, or even a gift certificate as well would be great!

This fantastic event is in its 17<sup>th</sup> year in Fallon, NV, starting out at the rodeo grounds for a few years then moving over to the park area for a few more years and now in the new RAFTER 3C ARENA Event Center! It's also the 22<sup>nd</sup> Anniversary of the sport of Cowboy Fast Draw! So hope you come and help make it another successful event and have fun while you're here, enjoying the cool indoor "weather."
