Meeting Minutes

July 24th, 2024

Call to order: 12:30 p.m.

- 1.) Introduction- Club Representatives and CFDA Management: 32 Voting Members Present.
- 2.) Opening Statements by Quick Cal & Alotta Lead
 - a. Future of CFDA NPO
 - b. Quick Cal's history past to present and hopes for CFDA in the future.
 - c. Advised careful social media posting re: firearms.
 - d. Jan 1st members will own a piece of CFDA. Encouraged the reading of the new bylaws.
- 3.) Recruiting is always the key to building your club & what is working and what is not. If your club isn't growing. It's in the process of dying!
 - a. Invitation to a Gunfight/Try Cowboy Fast Draw are great recruiting tools.
 - b. 7,400 members 5,000 inactive
 - c. CFDA is attractive because everyone had the chance to progress due to its challenging nature.
 - d. Recruiting suggestions:
 - VFW
 - American Legion
 - Radio promotion
 - CFDA make available a recruiting package of tools available for clubs
 - e. IT'S ALL ABOUT THE FOLLOW-UP!!!
 - Make sure to get all contact information when signing up as a new member and FOLLOW UP!!!
- 4.) Explain how clubs can se "Invitation to a Gunfighter" program. Best recruiting tool we have found.
 - a. Incorporate the "drawing box" to win a 1 on 1 training session. Call each entry and let them know they won! Who wouldn't be excited about winning something?

5.) Future agenda item proposed and supported for This Agenda (from Marshal's Muster 2023).

Discussion and Possible Action (Submitted by: Tin Bender – Northwest Rangers)

(5.A) Disqualification of repaired holsters...:

- a. How do we know if once a holster is checked, someone won't switch to a disqualified holster?
 - Suggestion: Mark holster <u>AND</u> gun to show both have been checked. Zip tie, sticker, yarn, concert/hospital bracelet (with event title on it) etc. were suggested for use.
 - If hand judge (or other) notices a shooter on the line w/ an unmarked holster. The shooter should be called on it and holster checked again. Crosswired
- b. Range Master's need to make it clear to hand judges that they be mindful of shooters holster.
- c. Can a holster be repaired back to its natural form (period correct)?

<u>Vote Taken:</u> Yes- 8 No-18. In an over 2-1 Opinion of the U.S. Marshals a Holster <u>Cannot</u> by Repair Back to its Natural Form.

- d. Will a temporary fix (at a Titled Match) be allowed if holster damage (excluding a blowout) is caused during a match?
 - Holster must be rechecked by the Range Master for safety. If it passes, is it approved for (only that) competition's completion? But must be done before the next round is shot. Vote Taken: Passed: Unanimously
 - Note: Damaged holsters must be repaired to period correct standards with period correct items (leather, rawhide, needle and thread etc.), rechecked and approved for use in further matches.
- e. Should Holsters AND Belts be marked once they pass safety check?

 Vote Taken: Passed: Unanimously Method

 Discussion: Various methods of marking holsters and belts were discussed like using zip-ties, etc. it was decided to leave methods up to contest Hosts for a period of time and re-address methods at the 2025 Marshals Muster. But some method of marking must be on the holster itself beginning in the 2025 Season.
- f. If a holster is switched during a CFDA Titled Match, should that Holster and Belt be checked? Vote Taken: Passed: Unanimously
- g. Should blowing out your holster be an automatic Round DQ?
 Vote Taken: Passed: Unanimously

- 6.) Extend Range Master Re-qualification for More Than 2 Years.

 Discussion & Possible Action (submitted by Dangerous Dave Eagle Rock Outlaws).
 - a. Per the rule book. Range masters have 1 year grace period AFTER they expire to recertify.
 - b. Regulators ARE Range Master instructors.
 - c. Match Director can appoint a Range Master on the spot if needed.

Decision: A regulator or Instructor can sign off on a Range Master Recertification

- 7.) 170-degree rule and can parts of the Shooters Body Extend Past the Firing line?

 Discussion and Possible Action (submitted by Witlock Cherry Valley Undertakers)

 -After an in-depth discussion a vote was taken. Majority ruled that no change should be made.
- 8.) Equipment Check Training (Discussion and Possible Action (submitted by Sandpoint Slim Treaty Rock Freedom Fighters).
 - a.) Concern over lack of consistency.
 - -Suggestion: A (laminated) outline or check list be made and placed in the gun check area so that all know what is expected of them. Keeps everyone on the same page.
 - -Suggestion: Holster/gun check video be made.
 - -Suggestion: A short demonstration at FGA yearly as a refresher.
 - -Suggestion: Equipment checks at club level matches for practice and educational purposes.
- 9.) CFDA as a Non-Profit Organization Important Discussion (submitted by CFDA management Quick Cal, Executive Director).
 - a.) Everyone seated at the table was asked if they had any questions or comments re: the newly written By-laws.
 - -"Well thought out & written." Dead Eye Daisy
 - Why are there some items not included in the granting of CFDA to the members?
 Answer: Some items will remain in the family.
 - How will Fastest Gun alive work once CFDA is granted?

Answer: TBD by The Board of Directors
