Statement By Board of Territorial Governors of the Cowboy Fast Draw Association, Non-Profit Organization (CFDA)

June 18th, 2025

The Cowboy Fast Draw Association, Non-Profit Organization <u>is not associated with Extreme Cowboy</u> <u>Fastdraw in any way!</u> Extreme Cowboy Fastdraw's format of staging western-style gunfights using Simunition in real revolvers for *"sporting purposes"*, rather *than "legitimate, law enforcement, military, security or selfdefense training"* is not proper and would be assessed a Major Safety Violation in any legitimate Shooting Sport.

The promotion of their start-up "game" by owner *Nephi Khaliki*, using outlandish language and brash videos while promoting similar behavior and trash talk between participants should never be tolerated behavior between opponents wearing firearms in any legitimate Shooting Sport. Promoting such a dark example leads to far-reaching and dangerous consequences like copy-cat behavior by certain disturbed members of the general public and sets a bad example for people of all ages, especially our young people and children.

As for members of the Cowboy Fast Draw Association, if you choose to participate in any Extreme Cowboy Fastdraw event, you will be in conflict with one of CFDA's main goals, "To Educate as Many People as Possible in the Safe and Proper Use of Firearms." Therefore, if it becomes known that any CFDA Member participates in any Extreme Cowboy Fastdraw event, after the publication date of this statement, your CFDA membership will be suspended by order of this Board for a minimum of 1-year.

We urge all legitimate Action Shooting Sports i.e., SASS, USPSA, IDPA, ICORE, CFDA, XFDA, WFDA, and all NRA Competition Programs, plus all established Range Officer & Training Programs, including Law Enforcement, Security, and Military to condemn any "sporting" activity that breaks the most Primary Safety Rule of All! "<u>Never Point a Firearm at Anything Unless You're Willing to Destroy It.</u>"
